# DUAL ADMISSION AND CORE-TO-CORE TRANSFER AGREEMENT BETWEEN COMMUNITY COLLEGE OF PHILADELPHIA AND RUTGERS UNIVERSITY—CAMDEN

### Preface

Community College of Philadelphia ("CCP") and Rutgers University—Camden ("RUC") enter into this Dual Admission Agreement and Core-to-Core Transfer Agreement ("Agreement") to facilitate the transfer of CCP students to RUC. This Agreement applies to both full-time and part-time undergraduate students entering RUC.

## **Dual Admission**

Under the Dual Admission Transfer Agreement, CCP students will be guaranteed admission into RUC with third year (junior) status at RUC on the condition that they:

- 1.e Submit an electronic Dual Admission Intent form before completion of no more than 45 collegee level credits from all colleges/universities attended;e
- 2.e Graduate from CCP with an approved Associate in Arts (A.A.), Associate in Science (A.S.) ore Associate in Applied Science (A.A.S.) degree with a minimum cumulative CCP GPA of 2.5<sup>1</sup>. A list of degrees/majors included in this Agreement are available in Appendix A. A.A.S. degreese not already listed in Appendix A will be considered for the Bachelor of Arts in Liberal Studiese only. Some degree programs (e.g. Nursing) may have additional admission criteria, and thee student must meet criteria of the program to which they apply; admission is not guaranteed fore each individual degree program.;e
- 3.e Complete an RUC Undergraduate Transfer Admissions Application within the last semester, e prior to their graduation from CCP, by a recommended date of November 1 for Springe admissions or July 15 for Fall admissions (for Nursing program, applications must be submittede by February 1<sup>st</sup> and transcripts must be received by February 15<sup>th</sup>); and satisfy all other regulare RUC admissions requirements;e
- 4.e Do not attend another institution of higher education between the time they graduate from CCPe and enroll at RUC;e

<sup>&</sup>lt;sup>1</sup> Certain majors may require higher GPAs. For example, the Nursing program requires a 3.0 GPA and decisions are made at the discretion of the schools, as of January 2018.

5.e Enroll at RUC within two semesters, excluding summer, of CCP graduation.e

Students who have previously matriculated to RUC are not eligible to return to RUC via this Agreement, but are encouraged to apply for reenrollment directly to RUC.

There is no obligation on the part of the dual admissions CCP student if the student decides not to transfer to RUC.

Once a student has submitted the Dual Admissions Intent Form, he or she is strongly encouraged to meet with an RUC Admissions Representative and/or a CCP Transfer Counselor or Program Advisor to develop a course taking strategy to maximize course transferability.

CCP graduates entering RUC under the terms of this Agreement go through the RUC normal transfer admissions process and therefore must meet all applicable RUC requirements and deadlines pertaining to application for admission, orientation and registration, and payment of tuition and fees. They will abide by the policies and procedures, and any revisions thereof, which apply to all RUC students.

#### **Transfer and Academic Guidelines**

1.e Only courses with a grade of "C" or higher will transfer to RUC for the degree.e

- 2.e RUC requires matriculated students to complete 50% of their major courses at RUC. RUC wille accept a maximum of 60 credits from two-year institutions.<sup>2</sup> . In addition, up to 30 credits can bee completed at a baccalaureate institution, CLEP, ACE or military transcripts for a total of 90e credits maximum. All students are required to complete their last 30 credits as matriculates of RUC. RUC residency requirement may be satisfied by taking Rutgers University courses offerede by Rutgers units at an off-campus location or on-line. Courses taken as exchange registration doe not apply to the residency requirement.
- 3.e Please note the combined total credits required to complete the degree could increase if ane articulated program is not followed or pre-requisite courses are not completed with the requirede grade to satisfy the requirement (C or better).e
- 4.e A full-time student admitted with third year (junior) status to RUC will be able to complete ae Bachelor's degree at RUC within four fall/spring semesters provided the student completes thee appropriate associate degree program at CCP and completes and appropriately sequences his/here remaining course work at RUC. If the student does not fulfill needed prerequisites for thee program in which they enroll at RUC during their associate degree program at CCP, thene additional credits or semesters may be required.e

<sup>&</sup>lt;sup>2</sup> Rutgers University has a policy that allows no more than half of degree credits to be awarded from an Associate's only degree granting institution. Rutgers is accredited by the Middle States Commission on Higher Education, and due to that accreditation, has created this policy that is also stated in our NJ Statewide Transfer Agreement with all NJ Community Colleges. Due to our accreditation and the university policy, Rutgers University – Camden- can allow no more than 60 credits to be transferred directly from Community College of Philadelphia to Rutgers University – Camden. Additional credits from bachelor's degree granting institutions, from military training and from ACE approved examinations will also be considered for transfer, up to a maximum of 90 credits.

5.e CCP graduates must submit final transcripts by October 15 to RUC for students enrolling in thee fall semester and February 15 for students enrolling in the spring semester at RUC.e

## <u>Core-to-Core</u>

The Core-to-Core Agreement applies to all CCP A.A., A.S. and A.A.S graduates with majors listed in Appendix A and is not limited to students who participate in the Dual Admission Agreement.

1.e CCP graduates with approved associate degrees will be waived from RUC general educatione requirements per the current catalog if the:e

a.e Math Requirement is fulfilled ande

- b.e English Requirement is fulfilled [Complete ENGL 101 & ENGL 102 at CCP].e
- 2.e CCP graduates not meeting the college level Math requirement will be required to take ae placement exam. FNMT 118 or higher at CCP will meet the college level Math requirement.e Some programs may require additional math courses for graduation.e
- 3.e CCP graduates may complete specific RUC school graduation requirements at CCP as part of e their associate degree. A grade of at least a C or better will be required for transfer.e

## **Financial and Scholarship Incentives**

To encourage CCP graduates to transfer to RUC, RUC agrees to the following:

- 1.e To waive the application fee for students who apply to RUC pursuant to this Agreement.e
- 2.e To award annual academic scholarships to all dual admissions graduates admitted to RUCe pursuant to this Agreement.e
  - •e All scholarships may be renewed each year contingent upon the students remaining in goode academic standing while at RUC.e
  - •e This scholarship is awarded for the fall and spring semesters only.e
  - •e Students may be also eligible for need-based financial aid and other types of financial aid.e
  - •e CCP students admitted under this Agreement will be provided with RUC financial aide information and receive full consideration for all RUC financial aid, including the Duale Admissions CCP RUC scholarships upon matriculation to RUC.e

# The Agreement:

To facilitate the transfer of CCP graduates to RUC in accordance with the foregoing guarantee, the parties agree to the following:

#### **Obligations of Rutgers University—Camden**

- 1.º To invite CCP students to an informational meeting with RUC faculty and staff on a regulare basis at both CCP and RUC to facilitate smooth curricular and co-curricular integration to RUC.e
- 2.e To send an RUC conditional letter of admission to all CCP students who submit a Duale Admission Intent form and a RUC application in accordance with the expectations stated in thee Dual Admission section of the Agreement and who meet the conditions set forth in the Duale Admission section.

Students will need to formally apply within the last semester prior to their graduation from CCP or no later than by November 1<sup>st</sup> for Spring admissions or July 15<sup>th</sup> (for RUC's Nursing program, students must apply by February 1st) for Fall admissions. A formal offer of admission is typically sent the semester before the students plan to matriculate. Students must confirm their intention to matriculate at RUC by confirming their acceptance and paying the acceptance fee by August 1<sup>st</sup> (for RUC's Nursing program, confirmation and acceptance fee payment is required by May 1<sup>st</sup>) for the fall semester, and by December 1<sup>st</sup> for the spring semester, and satisfy all other regular RUC admissions requirements. CCP students who submit a Dual Admission Intent form will be governed by the RUC degree requirements in effect at the time of submitting the Dual Admissions Intent form.

Students from the Philadelphia area who apply, but are not admitted to RUC, will be sent a letter encouraging them to attend and earn an appropriate associate degree from CCP to take advantage of the benefits of this Agreement.

CCP will receive a list from RUC of students denied and sent this letter so that they can follow up with the students.

- 3.e To support a Core-to-Core Articulation Agreement that allows the CCP A.A., A.S. or approvede A.A.S. degree (as listed in Appendix A) to fulfill all RUC General Education requirements.e Eligible CCP graduates enrolling at RUC will be identified by RUC upon admission to RUC, ande the fact that they have satisfied RUC General Education requirements by Core-to-Core transfere will be noted on all pertinent RUC student records. Core-to-Core transfer does not alter thee requirements of the student's major field of study or its admissions standards as identified in thee RUC catalog in effect at the time the student signed the Dual Admission Intent form. Core-to-Core transfer also does not necessarily satisfy all prerequisite requirements for the majore program that the student will enter. RUC will make every effort to provide prerequisitee information to CCP students in the information sessions, in the program-to-program transfere guides and through direct contact once the Dual Admission Intent form is signed by the student.e
- 4.e To encourage CCP transfer students to complete the appropriate associate degree beforee matriculation to RUC to take advantage of this dual admissions Agreement. If the CCP studente chooses to transfer and matriculate to RUC before completion of the associate degree, RUC will encourage reverse transfer. RUC will develop a reverse transfer credit process, which must bee mutually agreed upon by both RUC and CCP, that includes methodology to notify and assiste students with this reverse transfer benefit.e
- 5.e To continue working with CCP on program-to-program curriculum transfer guides that specifye for CCP transfer students the CCP courses that satisfy major requirements needed for degreee completion at RUC. To facilitate this, CCP and RUC agree to finalize program-to-programe transfer guides no later than 6 months from the signing of this Agreement.e

#### **Obligations of Community College of Philadelphia**

- 1.e To invite students to participate in this Agreement.e
- 2.e To publicize this Agreement to prospective students in its promotional literature.e
- 3.e To plan for RUC recruiters to visit CCP.e
- 4. To inform qualified students matriculating at CCP of the opportunity for Dual Admissions and Core-to-Core transfer to RUC under the terms of this Agreement.e

#### **Joint Obligations**

- 1.e To consult with each other through appropriate channels prior to implementing major changes ine policy or curricula that directly affect students transferring under the terms of this Agreement, e and keep each other informed of any other changes of policy or curricula that affect those students. Both RUC and CCP will review this Agreement annually and make any changes upone agreement, as needed. Such changes will become effective when both CCP and RUC sign thee revised document.e
- 2.e To collaborate in providing students with information and academic advising about thise Agreement, RUC's academic requirements, and the process of transferring to RUC.e
- 3.e To develop and implement advertising and promotional efforts to communicate the benefits of e Dual Admission and Core-to-Core transfer.e
- 4.e To designate a representative or representatives who will coordinate this Agreement between thee two institutions.e
- 5.e To exchange anonymous aggregate data annually that will contribute to the maintenance ande improvement of this Agreement, enhance the transfer process, and promote effective cooperatione between institutions.e
- 6.e To facilitate and support consultation and collaboration between their faculties related to thise Agreement, General Education, degree requirements, and other academic matters.e
- 7.e To provide direct links between RUC and CCP websites.e
- 8.e To continue their respective policies of nondiscrimination regarding sex, age, race, color, creed, e national origin, disability, sexual orientation, gender identity, veteran status or any other statuse protected by Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments Acte of 1972, the American with Disabilities Act, or any other applicable federal, state, or local law.e The parties agree to reasonably cooperate with each other in any investigation of claims of e discrimination or harassment, to the extent permitted by law.e

#### **Revision, Renewal and Termination of this Agreement**

The Rutgers University—Camden Vice Chancellor for Enrollment Management and the Vice President for Academic and Student Success at Community College of Philadelphia or their designees are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this Agreement. Modifications to the terms and conditions of this

Agreement may only be made by written agreement of the parties. Until such modification by mutual written agreement, the then-current terms of the Agreement shall remain in effect.

This Agreement will be in effect as of the date of its signing, for students entering RUC on or after January 1, 2018, and will continue in effect for five (5) years unless otherwise modified or terminated in accordance with this Agreement.

Either institution may terminate this Agreement at any time by written notice at least one year in \_\_\_\_\_\_ advance of the effective date of termination. Should this Agreement be terminated, it is understood that students already accepted to RUC through the effective date of termination will continue to receive the benefits articulated in the original terms of the Agreement.

Provided that all parties execute a copy of this Agreement, this Agreement may be executed in counterparts, each of which shall constitute an original, and all of which together shall constitute one and the same document. This Agreement may be executed by the parties and transmitted by facsimile or electronic transmission, and, if so executed and transmitted, shall be effective as if the parties had delivered an executed original of this Agreement.

The willingness of both institutions to enter this Agreement to facilitate the transfer of students from CCP into RUC, and to expand their opportunities for academic success there, is indicated by the following signatures.

The undersigned representatives of the parties, Community College of Philadelphia and Rutgers University—Camden, have executed this Agreement on the date indicated below:
