DUAL ADMISSIONS PARTNERSHIP TRANSFER AGREEMENT

As part of the Dual Admissions Agreement, Community College of Philadelphia ("CCP") graduates are guaranteed conditional admission into Saint Joseph's University ("SJU") pre-approved bachelor degree programs in Professional and Liberal Studies and Haub Degree Completion ("Programs") if they have completed and submitted a Dual Admissions Intent Form before completing no more than forty-five (45) credits; graduate from CCP with a designated Associate in Arts (A.A.) or Associate in Applied Science (A.A.S.) and satisfy SJU transfer admission requirements. The Associate degrees designated as part of the SJU Dual Admissions Agreement are described in Exhibits A and B of this Agreement ("Degrees").

TRANSFER ADMISSIONS REQUIREMENTS:

- 1. Students must achieve a minimum cumulative CCP grade point average (GPA) of 2.5 within a preapproved associate's program of study. All CCP transferable courses with an earned grade of C or higher and a minimum of 3.00 credit hours will be eligible for transfer to SJU.
- 2. Students must submit an electronic Dual Admissions Intent to Enroll Form before completing no more than a total of 45 credits from CCP or any other institution. Students who complete this intent form will also be required to complete the appropriate SJU application within their last semester at CCP (or earlier), for which there is no application fee.
- 3. Upon transfer to SJU, students are required to fulfill all remaining requirements for the bachelor degree, to include major, general education and elective requirements. Once a student has submitted the intent form, he or she is *strongly encouraged* to speak with a SJU-PLS or SJU-HDC admissions representative and a CCP Transfer Counselor or Program Advisor to develop a course taking strategy so as to maximize course transferability.
- 4. A maximum of 75 credits are eligible for transfer to SJU-PLS or SJU-HDC from CCP. Transfer credits will be accepted on the basis of their relevance to the requirements of each bachelor's degree program. Students must complete a minimum of 45 credits at SJU in any SJU-PLS or SJU-HDC major to be eligible to receive a Saint Joseph's University degree.
- 5. Bilingual students and/or non-native English speakers may be eligible to waive the SJU Foreign Language requirements through an examination administered by the SJU Modern & Classical Languages Department. Should a student receive a waiver of one or more of these classes, free electives will be substituted.

- 6. This Dual Admissions Transfer Agreement does not alter SJU's admission standards or its requirements for various fields of study. Students are encouraged to follow the established CCP SJU GEP Transfer Credit Guide (Exhibit C) to maximize their transfer credit opportunity. Students who wish to major in business through the SJU-HDC program should also see the Business Core Transfer Guide (Exhibit D) for a list of transferrable business courses. Students must enroll directly to the designated SJU Bachelor Degree Program within two years of completing an associate degree from CCP without attending any other institution between CCP graduation and matriculation at SJU.
- 7. Credits earned at other institutions that appear on a student's CCP transcript would be subject to review of the original, official, sealed transcripts from that institution by SJU to determine transferability.
- 8. CCP course credits earned through an Advanced Placement (AP) exam, CCP challenge exam, Defense Activity for Non-Traditional Students Education Support Program (DANTES) or the Prior Learning Assessment Program, for which no course grade is listed on the CCP transcript, would be subject to review by SJU-PLS and SJU-HDC. Automatic transfer of credit may not be granted.
- 9. CCP course credits earned through the College Level Examination Program (CLEP) for which no course grade is listed on a transcript would be subject to review by SJU. In such cases, a student would be required to request an official CLEP score report from the College Board to be reviewed by SJU. Automatic transfer of credit may or may not be granted.
- 10. Full-time students entering SJU-PLS or SJU-HDC with 60 or more transfer credits will typically be able to complete a bachelor's degree within four regular full-time terms (spring and fall) in a parallel program, provided the student completes the designated associate degree program at CCP and completes the appropriate sequence of courses at SJU. Work, family, and other obligations influence the pace of adult and part-time students' academic careers. Therefore, degree completion time varies for individual student. SJU offers two summer sessions, a January intersession, accelerated and online courses to help students work towards their degrees more quickly.
- 11. Students who have pursued an associate's program of study other than those designated in this agreement may have their CCP credits evaluated on a course-by-course basis.
- 12. In cases where a CCP associate degree curriculum changes, SJU reserves the right to evaluate changed courses to determine if they meet SJU-PLS and SJU-HDC course equivalencies.
- 13. CCP and SJU agree to continue working on Program-to-Program transfer guides that specify for CCP transfer students the CCP courses that satisfy major requirements for degree completion at SJU.
- 14. CCP and SJU agree to work towards enhancing the transfer process and promote effective cooperation between the institutions. This includes dissemination of general data regarding Dual Admissions Transfer Agreement student performance.

SCHOLARSHIPS & FINANCIAL AID for Full or Part-time Students:

Merit Scholarships: CCP Dual Admissions transfer students who enroll on a full-time (12+ credits) or part-time (9 or 6 credits) basis are eligible to receive a merit scholarship based on their CCP transfer Grade Point Average (GPA). This applies to CCP students applying to any program in HDC or PLS at SJU.

Merit award designed for transfer students (including Phi Theta Kappa) with a 3.0 or higher.

The Transfer Merit Scholarship is designed for all continuing transfer students, including members of the Phi Theta Kappa National Honor Society who have demonstrated scholastic achievement. To be considered for this award, the student must be fully admitted to SJU as a full or part-time undergraduate, must have a minimum of 60 transferable credits and an associate's degree, a minimum 3.0 GPA, be seeking his or her first time bachelor's degree, be attending SJU for the first time and meet specific scholarship program criteria. Non-US citizens are not eligible for this award.

- SJU-HDC will use a student's transfer GPA to calculate award amounts for the first matriculated semester only. After that time, the award amount may vary based on the student's SJU GPA and the amount of credits registered for a particular semester. If the student's SJU GPA drops below 3.00, the student is not eligible to receive a merit scholarship. A student may not be eligible for additional scholarship and merit scholarships at the same time.
- SJU-PLS will use the transfer GPA from CCP for merit scholarship award calculations. SJU-PLS will not recalculate a student's award based on their SJU GPA, but the amount of credits a student is registered for will affect the award amount. If SJU GPA drops below 3.00, a student is not eligible to receive a merit scholarship.
- Scholarships are renewable, contingent upon the student maintaining a required cumulative grade point average of 3.0 while attending SJU.
- Students attending SJU's off-campus locations at a discounted tuition rate are not eligible for merit or transfer scholarships.
- Students attending SJU's exclusively Online Degree Completion through SJU-PLS programs are

not eligible for merit or transfer scholarships. SJU-HDC students studying exclusively online ARE eligible for merit-based scholarships.

- Financial Aid will be awarded to Dual Admissions students on the same basis as all SJU-PLS and SJU-HDC students. They will have equal access to all state and federal financial aid programs.
- Merit Scholarships are awarded for the fall and spring semesters only.

Please note that students are strongly encouraged to complete the Free Application for Student AID (FASFA) before May 1st each year to determine if they are eligible for a state grant.

REVISION, RENEWAL, AND TERMINATION OF THE AGREEMENT

The SJU-PLS Office and SJU-HDC Office and appropriate offices at CCP are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this Agreement. This Agreement will be in effect as of April 1, 2016 for students entering SJU. This Agreement shall be in effect for an initial two year term beginning on April 1, 2016 and terminating two years after in March 31, 2018 unless terminated as provided below.

This Agreement may be renewed for successive two year terms upon the written agreement of both parties within 30 days prior to the end of the then current term. Notwithstanding anything set forth herein to the contrary, either party may terminate this Agreement upon 60 days prior written notice to the other party.

Should this Agreement be terminated, it is understood that the termination will not apply to the students already accepted to SJU-PLS or SJU-HDC Programs under the terms of this Agreement, but not yet enrolled in courses at Saint Joseph's University. The willingness of both institutions to enter this Agreement in order to facilitate the transfer of students from the Community College of Philadelphia to Saint Joseph's University and to expand their opportunities for academic success is indicated by the following signatures.

This Agreement is the complete, entire and fully integrated agreement between the Parties. This Agreement (including any exhibits attached hereunder) supersedes and replaces all prior or contemporaneous understandings, agreements and discussions, whether oral or written, between the Parties.

The undersigned representations of the parties, Community College of Philadelphia and Saint Joseph's University, have executed this Agreement on the dates indicated.

Only graduates from these programs are guaranteed admission into the corresponding SJU-PLS majors:

- Associate in Applied Science (A.A.S.) American Sign Language/English Interpreting (INT) to Bachelor's Degree in General Studies with Humanities Concentration.
- Associate in Arts (A.A.) Communication Studies to a Bachelor's Degree in General Studies with Humanities Concentration or Professional Studies Concentration.
- Associate in Arts (A.A.) Health Service Management to Bachelor's Degree in Health Administration.
- Associate in Arts (A.A.) Liberal Arts to Bachelor's Degree in General Studies. The concentration will be determined by the student's interests and elective choices at CCP.
- Associate in Arts (A.A.) Liberal Arts Social/Behavioral Science to Bachelor's Degree in General Studies with Social Sciences Concentration.
- Associate in Applied Science (A.A.S.) Justice to Bachelor's Degree in Criminal Justice Studies.
- Associate in Arts (A.A.) English to Bachelor's Degree in English & Professional Writing or Bachelor's Degree in General Studies with Humanities Concentration.
