DUAL ADMISSION TRANSFER AGREEMENT MEMORANDUM OF UNDERSTANDING SHIPPENSBURG UNIVERSITY OF PENNSYLVANIA AND COMMUNITY COLLEGE OF PHILADELPHIA

Preface

This agreement is made in accordance with the Pennsylvania State System of Higher Education (PASSHE) Student Transfer Policy (Policy 1999-01-A) and General Education at State System of Higher Education Universities Policy (Policy 1993-01-A), in addition to all applicable Pennsylvania Statewide Program-to-Program Articulation Agreements approved by the Transfer Articulation and Oversight Committee (TAOC). Herein, Community College of Philadelphia (CCP) and Shippensburg University of Pennsylvania (SU) enter into this Dual Admission Transfer Agreement to facilitate the transfer of CCP graduates to Shippensburg University of Pennsylvania.

The purpose of the Dual Admission Program is to enhance the relationship between CCP students and SU. The goal of this program is to establish Dual Admissions and in the process, eliminate anxiety, and reduce attrition that is often found with transfer shock. The Dual Admission program provides CCP students with articulated curricula and policies that lead to a bachelor's degree at SU. Students pursue their bachelor's degree through seamless enrollment from an associate degree program at CCP through upper-division coursework at SU.

Under the Dual Admission Agreement, CCP students will be guaranteed admission into a Bachelor's Degree program with third year (junior) status at SU on the condition that they: graduate from CCP with an eligible Associate in Arts (A.A.) or Associate in Science (A.S.) degree in a parallel program, with a minimum cumulative GPA of 2.0; complete a Dual Admission Intent form; complete an Application for Admission to SU; and satisfy all other SU transfer requirements, including major specific GPA and/or course pre-requisite requirements.

To facilitate the transfer of CCP graduates to SU in accordance with the foregoing guarantee, the parties agree to the following:

Financial and Scholarship Incentives

- 1. SU agrees to waive the application fee for students who apply to SU pursuant to this Agreement.
- 2. SU agrees to award academic scholarships annually to all Dual Admission students admitted to SU pursuant to this Agreement:

Full time (enrolled in 12 or more credits a semester) at SU

- 3.0 4.0 final cumulative GPA will receive a minimum of \$4,000/year (\$2,000 per semester)
- 2.5 2.99 final cumulative GPA will receive a minimum of \$2,000/year (\$1,000 per semester)
- 3. Students must earn their Associate's Degree and must be enrolled full-time (12 or more credits) at SU.
- 4. Scholarships may be renewed each year, up to 4 years for undergraduate study, contingent upon the student remaining in good academic standing at SU with a 2.8 cumulative GPA.¹

¹Updated language to 4 years which is consistent with other transfer scholarships. Only applies to undergraduate study and students must be enrolled full time. Is not dependent on financial aid status so FAFSA does not need to be submitted.

- 5. The scholarship is awarded for fall and spring semesters only.
- 6. SU agrees to treat CCP students in the same manner as other SU students of equal class standing when applying for financial aid and in the award and distribution of funds, subject to appropriate regulations.

Obligations of SU

- 1. SU agrees that if a student satisfactorily completes the Associate of Arts or the Associate of Science Degree from CCP and presents the appropriate transcript documentation of such to the Registrar of SU, he/she:
 - a. Will receive full recognition of that degree and will have all credits applied (to a parallel program) toward the completion of a bachelor's degree; and
 - b. Will be awarded a bachelor's degree after the appropriate personnel at SU have determined that the requirements for the baccalaureate degree have been completed.
 - c. Residency degree requirements include completion of at least 30 of the last 60 credits at SU with at least half of the major coursework completed at SU.
- 2. SU agrees to waive diagnostic (or placement) testing for CCP students who have earned a grade of "C" or better in the appropriate college level general education courses in communication and computation².
- 3. Although all credits in a completed associate degree will transfer, minimum grades required for subsequent courses or to meet program requirements will still apply. The transfer of D grades³ will be reviewed in the same manner as the grading policy of native SU students so long as the student has earned their A.A. or A.S. degrees with a minimum GPA of 2.00. Further agreements and processes may need to be arrived at to operationalize this.
- 4. D grades are considered unsatisfactory but passing. In certain cases, a grade of D may not be considered passing; and a student may be required to repeat the course by their major department. Examples include courses for majors where C grades or higher are required for all major coursework or eligibility to take a course in a sequence that requires a C or higher in the required pre-requisite course.
- 5. SU agrees to attend regularly scheduled Partner Day Programs at CCP.
- 6. SU will notify the student at the time of dual admission of all entrance to major requirements (*Appendix B*). Students will be governed by the SU degree requirements in effect at the time of dual admission as long as the student maintains continuous enrollment.
- 7. Within 30 days of receipt of the Dual Admission Intent Form report from CCP, SU will send a letter of acceptance into the Dual Admission program to all CCP students who complete the enrollment process and meet the conditions set forth in the Preface. Students must confirm their intention to matriculate at SU by **August 1st** for the fall semester, and by **January 5th** for the spring semester, and satisfy all other SU transfer requirements. students who complete a Dual Admission Intent Form will be governed by the SU degree requirements in effect at the time of enrolling in the Dual Admission program.

- 8. SU Transfer Admissions staff will contact Dual Admission students directing them to complete the Application for Admission to SU at the beginning of the academic cycle during which the student intends to enroll at SU.
- 9. SU agrees to ensure that all courses for which a passing grade (A, B, C or D) was received will transfer to SU, unless a grade of C or higher is required of native SU students.
- 10. SU agrees to ensure that CCP graduates entering SU under the terms of this Agreement will go through the SU transfer process and therefore must meet all applicable SU requirements and deadlines pertaining to orientation and registration, and payment of tuition and fees. They will abide by the policies and procedures, and any revisions thereof that apply to all SU students.
- 11. SU agrees to work with CCP on Program-to-Program Transfer Agreements and/or Guides that specify for CCP transfer students the CCP courses that satisfy major requirements for degree completion at SU. To facilitate this, CCP and SU agree to finalize program-to-program transfer guides for the most popular programs no later than 6 months from the signing of this Agreement. All transfer guides will be posted on CCP's SU webpage for easy access to the CCP community to assist students in choosing appropriate courses.
- 12. SU agrees to ensure that CCP students who matriculate under this agreement at SU have all of the rights, privileges, and responsibilities of native SU students.
- 13. Students will receive an official letter of admission from SU during their last year at CCP once an official CCP transcript with the most recent coursework and grade information has been submitted. Upon receipt of the final transcript, SU will complete an official final transcript evaluation. This will be completed prior to matriculation to SU.
- 14. SU agrees to send students from the Philadelphia area who apply but are not admitted to SU a letter encouraging them to attend and earn an appropriate associate degree from CCP so as to take advantage of the benefits of this Agreement. CCP will receive a list from SU of students denied and sent this letter so that they can follow up with the students.
- 15. SU will encourage CCP transfer students to complete the appropriate associate degree before matriculation to SU in order to take advantage of this Agreement. If the CCP student chooses to transfer and matriculate to SU before completion of the associate degree, SU will encourage reverse transfer and use the reverse transfer credit process mutually agreed upon by both CCP and SU, in the Statewide Reverse Transfer Agreement.

Obligations of CCP:

- 1. CCP agrees to publicize this Agreement to prospective and current CCP students in its promotional literature, and arrange for SU recruiters and advisors to visit CCP and meet with prospective and current Dual Admission students.
- 2. Inform CCP students of the opportunity for Dual Admissions transfer to SU under the terms of this Agreement. As such, qualified students will be encouraged to submit an electronic SU Dual Admissions intent form through their MyCCP portal system. The system will determine whether students qualify for Dual Admissions for SU as outlined in this Agreement and therefore only those will be allowed to submit

Fall 2020 | August 21, 2020 an intent form for SU.

- 3. CPP will send SU a report of all students who have completed the electronic Dual Admissions Intent Form for Shippensburg University within that given time. This report includes student academic history while at CCP.
- 4. As part of submitting a Dual Admissions intent form through CCP's electronic system, students automatically provide written consent for release of information between both institutions necessary to facilitate the admissions process and to ensure the requirements of the program are met.
- **5.** Students may apply for Dual Admission as early as their senior year of high school but not later than the completion of 30 college-level credit hours at CCP.
- 6. Students who have been accepted into the Dual Admission Program must enroll at SU within one year of CCP graduation and may not attend another institution between the time the student graduates from CCP and commencement of enrollment at SU.
- 7. Students who have previously matriculated to SU are not eligible for Dual Admission but are encouraged to apply for readmission to SU.
- 8. There is no obligation on the part of the Dual Admission CCP student if the student decides not to transfer to SU.
- 9. Students must meet all SU admissions requirements, including grade point average for their intended major. Under this program and per the Pennsylvania State System of Higher Education Transfer Student Policy (Policy 1999-01-A) and TAOC agreements, students who do not complete an Associate Degree will not be granted automatic admission to SU. Some majors require special standards and GPA requirements for admission. The SU admissions requirements will be made available to CCP on an annual basis (*Appendix B*).
- 10. Students may change their CCP or SU major at any time; however, students choosing to change their major at CCP or their intended major at SU after submitting a Dual Admissions intent form for SU, are not guaranteed third year (junior) status unless they choose matching majors as listed in Appendix A. They will still be required to meet entrance requirements for the new SU major at the time of change.

Joint Obligations:

- 1. To inform each other through appropriate channels within one semester prior to implementing major changes in policy or curricula that directly affect students transferring under the terms of this Agreement, and keep each other informed of any other changes of policy or curricula that affect those students. Both SU and CCP will review this Agreement annually and make any changes upon mutual agreement, as needed. Such changes will become effective when both CCP and SU sign the revised document.
- 2. To collaborate in providing students with information and academic advising about this Agreement, SU academic requirements, and the process of transferring to SU.
- 3. CCP and SU jointly agree to develop and implement advertising and promotional efforts to communicate the benefits of this transfer articulation. Mutually acceptable agreements will be arrived to grant and receive permissions to use the respective school logos in marketing materials and to acquire approval rights over marketing materials.

- 4. To designate a representative or representatives at each institution who will coordinate the Dual Admission Transfer Agreement between the two institutions.
- 5. To exchange data and documents, as permitted by law, annually that will contribute to the maintenance and improvement of this Dual Admissions Agreement, enhance the transfer process, enhance and extend each institution's overall student-related data assets, and promote effective cooperation between institutions. These will consist of individual and aggregate data about transfer students, including admissions information, academic progress and retention information, and reports on the results of program reviews, assessments of student learning, and decisions of curricular and other committees. The institution(s) will exchange data after obtaining appropriate permission from the students as indicated on the Dual Admission Intent form.
- 6. To facilitate and support consultation and collaboration between their faculties related to this agreement, general education, degree requirements, and other academic matters.
- 7. To provide direct links between SU and CCP websites.
- 8. The SU Office of Admissions and the appropriate offices at CCP are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this Agreement.

Mutual Terms and Conditions

- 1. *Term of Agreement*. The term of this Agreement shall be 5 years from the date of full execution by the authorized representatives of SU and CCP. This Agreement may not exceed a period of five years at which time it will be reviewed.
- 2. *Termination of Agreement*. Either party may terminate this Agreement at any time by written notice at least one year in advance of the effective date of termination. Should this Agreement be terminated, it is understood that the termination will not apply to students already accepted to SU or who have already completed a Dual Admission Intent form under the terms of this Agreement.
- 3. Nondiscrimination. The parties will abide by their respective policies of nondiscrimination in regard to sex, age, race, color, creed, national origin, disability, sexual orientation, gender identity, veteran status or any other status protected by Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments Act of 1972, the American with Disabilities Act, or any other applicable federal, state, or local law. The parties agree to reasonably cooperate with each other in any investigation of claims of discrimination or harassment, to the extent permitted by law.
- 4. *Interpretation of the Agreement*. The laws of the Commonwealth of Pennsylvania shall govern the interpretation and enforcement of this Agreement. CCP and SU shall at all times under this Agreement comply with all Federal, State, and local laws and respective institutional policies.
- 5. *Modification of Agreement*. This Agreement shall only be modified in writing with the same formality as the original Agreement.
- 6. Relationship of Parties. The relationship between the parties to this Agreement to each other is that of independent contractors. The relationship of the parties to this contract to each other shall not be construed to constitute a partnership, joint venture or any other relationship, other than that of independent contractors.

- 7. *Liability.* Neither of the parties shall assume any liabilities to each other, except as specifically stated in this Agreement. As to liability for damage, injuries or death to persons, or damages to property, the parties do not waive any defense as a result of entering into this Agreement unless such a waiver is expressly and clearly written into a part of this Agreement.
- 8. *Entire Agreement*. This Agreement represents the entire understanding between the parties. No other prior or contemporaneous oral or written understandings or promises exist in regards to this relationship.
- 9. Confidentiality. The parties shall protect the confidentiality of student records as dictated by the Family Educational Records and Privacy Act (FERPA) and shall release no information absent written consent of the student unless required to do so by law or dictated by the terms of this agreement.
- 10. Execution of Agreement: Provided that all parties execute a copy of this Agreement, this Agreement may be executed in counterparts, each of which shall constitute an original, and all of which together shall constitute one and the same document. This Agreement may be executed by the parties and transmitted by facsimile or electronic transmission, and, if so executed and transmitted, shall be effective as if the parties had delivered an executed original of this Agreement.
