

GENED-TO-GENED TRANSFER AGREEMENT
between
COMMUNITY COLLEGE OF PHILADELPHIA
and
TEMPLE UNIVERSITY Of The Commonwealth System of Higher Education
(Effective Spring 2023)

Community College of Philadelphia (CCP) and Temple University Of The Commonwealth System of Higher Education (Temple) enter into this agreement in order to facilitate the transfer of students from CCP into Temple, and to support their academic success in baccalaureate degree programs.

This agreement applies to students who first enroll at Temple for or after the Spring 2023 term and have received an associate degree from CCP in one of the programs specified below that includes their new General Education curriculum (effective Fall 2021). Students who enrolled at CCP prior to Fall 2021 will be subject to the previous GenEd-to-GenEd agreement.¹

For those students, Temple agrees to accept the revised general education embedded in the CCP degree programs in lieu of all the requirements for its undergraduate University General Education (GenEd) curriculum. As described below, some CCP degrees are approved for GenEd-to-GenEd transfer if and only if **students are certified by CCP** as having completed certain mathematics, or social science and/or humanities courses.

Other CCP degrees that incorporate the same requirements as one of these degrees may be added to this agreement in the future, if after review and approval each institution considers it appropriate, and by mutual consent.

The following Community College of Philadelphia associate degrees are eligible for GenEd-to GenEd transfer:

The following CCP associate degrees are approved if and only if the student is certified through CCP's Pathway process as having completed a mathematics course that satisfies Temple's Quantitative Literacy requirement. The following CCP associate degrees are approved if and only if the student is certified through CCP's Pathway process as having completed five social science and/or humanities courses:

Chemistry, A.S.

Engineering Science, A.S.
Mathematics, A.S.

CCP associate degrees either not specified above or not certified as described above are not eligible under the terms of this agreement. Students who first enroll at Temple for or after the Spring 2023 term and have received an associate degree from CCP that is not specified above or not certified as described above will complete the 45+ GenEd curriculum. Courses from these degrees follow established transfer equivalencies.

Eligible CCP graduates enrolling at Temple will be identified upon receipt of final transcript. Satisfaction of Temple's GenEd requirements pursuant to this agreement will be noted on all pertinent student records. GenEd-to-GenEd transfer does not alter the requirements of the student's major field of study or the requirements of the student's Temple school or college. Under the terms of this agreement, students will need to complete two Writing-Intensive courses at Temple. These courses will be determined by the student's major.

CCP graduates entering Temple under the terms of this agreement will go through Temple's normal transfer admissions process and therefore must meet all applicable Temple requirements and deadlines pertaining to application for admission, orientation and registration, and payment of tuition and fees. Such CCP graduates will abide by the policies, procedures, and any revisions thereof, that apply to all Temple students. Temple University requires that all undergraduate degree candidates complete 45 hours of the last 60 hours of the degree or program as matriculated students at Temple University. If a matriculated student previously took Temple courses on a non-matriculated basis, those courses are counted towards this requirement.

This agreement does not change the regular Temple policy that grants transfer credit to courses taken elsewhere only if they were completed with a grade of C or higher. Nor does this agreement waive the minimum score requirements for transfer credit through testing e.g. Advanced Placement Tests, International Baccalaureate Exams, the College Level Examination Program, or DANTES Subject Standardized Tests. While students may transfer under this agreement, should they not meet transfer grade or score requirements, those credits will not be counted by Temple toward graduation. Both institutions agree to:

- 1) Consult with each other through appropriate channels prior to implementing major changes in policy or curricula that directly affect students transferring under the terms of this agreement and keep each other informed of any other changes of policy or curricula that affect those students.
- 2) Collaborate in providing students with information and academic advising about this agreement, Temple's academic programs and requirements, and the process of transferring to Temple.
- 3) Exchange data and documents that will contribute to the maintenance and improvement of this GenEd-to-GenEd agreement, enhance the transfer process, and promote effective cooperation between institutions. When required by law, the institutions will exchange data only after obtaining appropriate permission from the student.
- 4) Facilitate and support consultation and collaboration between their faculties related to this agreement, general education, degree requirements, and other academic matters.
- 5) Comply with all applicable laws, rules, and regulations in performing their respective obligations under this agreement, including but not limited to all laws, rules and regulations prohibiting discrimination.

REVISION, RENEWAL and TERMINATION OF THIS AGREEMENT

Temple's Office of Undergraduate Studies and appropriate offices at CCP are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this agreement.

This agreement will be in effect as of the Spring 2023 term, for students entering Temple in or after Spring 2023. It will be reviewed annually by the appropriate parties at each institution and will be renewed automatically until superseded by a new agreement or formally terminated. Either institution may terminate this agreement by giving written notice to the other party at least one year in advance of the effective termination date. Should this agreement be terminated, it is understood that the termination will not apply to students already accepted to Temple under the terms of this agreement, but not yet enrolled in classes at Temple.

CCP and Temple understand that they shall act in an independent capacity in the performance of this agreement, and shall not be considered as employees, agents, affiliates, or subsidiaries of each other. Neither Temple nor CCP have the right to bind or obligate one another in any manner inconsistent with or unrelated to this agreement. This agreement is governed by the laws of the Commonwealth of Pennsylvania without regard to its conflicts or choice of law provisions.
