# **Proposed Changes**

The two-fold purpose of this revision is to 1) eliminate the requirement of either OA 141 or OA 102 in the Accounting Curriculum and 2) bring the curriculum into compliance with the new General Education Plan.

# **Rationale/Description of the Changes**

# 1) Elimination of the requirement of either OA 141 or OA 102

As CIS 103 – PC Applications is sufficient preparation for the computer skills required in the business workplace and also satisfies the Technology requirement in the General Education Plan, the OA requirement is no longer necessary. This change was approved by the Economics and Accounting Department faculty in January 2008.

# 2) Compliance with General Education Requirements

- A) The English elective will become the Humanities elective.
- B) The Science/Math elective will become the Science elective.
- C) English 112 will be eliminated as an acceptable alternative to English 102.
- D) One Social Science elective will be eliminated.
- E) Math requirements are being expanded to include MATH 171 as an acceptable option.

# **Effects of the Revision**

The above changes decrease the minimum number of credits needed to graduate by four credits, from 66 to 62.

# Accounting

The Accounting curriculum leads to an Associate in Applied Science (A.A.S.) degree. Students receive training in accounting theory and generally accepted accounting techniques, as well as in basic management and related fields. Students are prepared for a variety of careers in both industry and government, including positions such as junior accountant, accounting trainee, accounts receivable or accounts payable technician, or tax examiner.

### **Student Learning Outcomes:**

Upon completion of the Accounting curriculum, the student will be able to:

- 1. Understand financial statements prepared according to Generally Accepted Accounting Principles (GAAP), prepare journal entries and complete the accounting cycle using computerized general ledger software
- 2. Understand and utilize managerial and cost accounting concepts
- 3. Analyze and interpret financial statements for economic decision-making
- 4. Effectively communicate with users of financial information orally and in writing

### **Program Entry Requirements:**

The program is open to interested students, assuming space is available. However, all new students are normally required to take the College's placement tests at their time of entry. Students identified as needing developmental course work must satisfactorily complete the appropriate English and mathematics courses as a part of their degree program.

### **Program of Study and Graduation Requirements:**

A minimum of 62 credits and a grade point average of 2.0 ("C" average) are required for graduation.
