III. Discussion:

Regarding "Process and procedure for "how to and who may" propose policy to Committee"
Pam Gallimore was invited to discuss this topic. At the last meeting there was a question related to the purpose of standing committee's role in proposing policy. This question came up once before.

In a prior meeting, Fran brought up the issue weather the standing committee has the authority to bring up policy.

Pam stated that if the committee were to put forward a policy recommendation, it infers everyone agrees with policy, language, and intention. If everyone does not support it, it has to be discussed and vetted. Any individual can suggest policy. It does not have to be the committee. The concern is if the students are on board. The committee and the policy are not tied together. Pam is working with the Federation on process documentation.

Sandra inquired, because we have sub groups and we are each working on different topics, do we bring those to the table or do we propose when it's ready for voting. To this, Diane suggested bringing it back to the committee rather than working in isolation.

Regarding the "Add Policy":

Malika Rochester, student would like to join this group. Current members include: Bhavesh, Susan Tobia and Diane Freedman.

Discussion surrounded review of current add procedure within the Spring 09 Course Schedule book (a photocopy of page 17 was handed out). Students (not previously in attendance) supported the need for this to be procedure to be developed into a formal policy. They agreed that the policy needs to be standard and campus wide.

Regarding "Academic Honesty":
