Marge Niven also announced that in her role as Assistant Dean, she has been asked to work on the issue of Academic Honesty as a College-wide issue. All agreed that Marge, Bettsy and all other members of last year's Academic Honesty team should meet to plan next steps.

## Drop / Add Policy

Diane Freedman distributed a handout/document; she also explained history and an update on the status of the Drop and Add Policy. The Add policy was approved by Academic Support Sub-Committee (us) last year. In light of this approval, it was recommended that the Drop policy be reviewed as well. Work on the Drop policy led to further work on clarifying the Withdraw procedures.

The document was discussed. Discussion took place around the interpretation of: "part-of-term", "add", "drop", and "withdrawal." This is a discussion the Committee had last year but with new members, it was important that everyone understand these definitions. Confusion has apparent as members of the committee understood the terminology from their own perspective. As before, it was concluded that there needs to be institution wide awareness on the terminology of "part-of-term".

Further discussion developed when members were reminded about the differences between the academic policies and financial aid policies. Sandra Hernandez-Mejia suggested that anyone trying to assist students with questions about the financial aid policies simply send the student to the Financial Aid office. The important part is making sure that all know that there are two different policies.
