- I. Call to Order-** The meeting was called to order at 3:35pm.

- III. Election of Chair**
A. Jim Spiewak explained to the committee that the first order of business is to elect a chairperson(s). Jim briefed everyone that for the past few years the committee has elected co-chairs. He opened the floor to nominations for the post. Miles Grosbard nominated both Kristy Shuda McGuire and Jim Spiewak. Harry Moore seconded the nomination. There were no other nominees and by unanimous vote both nominees were reelected to serve as co-chairs of the committee.

- A.** Minutes from May 13, 2015 were not available to approve. Kristy will follow up with Cathy Blaine.
 - B.** Jim Spiewak briefed the committee on past years' accomplishments of the committee.
 - C.** Kristy Shuda McGuire briefed the committee on the progress of the Legacy Smoke-Free and Tobacco-Free Community College Grant received last spring. Kristy explained that this grant will have a second round of funding for which she would like to apply. The initial thrust of the project is focused on placing signage to encourage smoking cessation. A question was asked about whether a smoking shelter would be provided and answered that it was not in plans to support the installation. Rick Frei and his students will be conducting a smoking survey this semester and presenting the results at a conference on Tuesday, November 24th.
 - D.** Miles Grosbard asked about the status of the Presidents' Climate Commitment. It was explained that the President still has the document under review.
